ORDINANCE 2016-05

AN ORDINANCE ASCERTAINING THE GENERAL PREVAILING RATE OF WAGES FOR LABORERS, MECHANICS AND OTHER WORKERS ENGAGED IN CONSTRUCTION OF PUBLIC WORKS COMING UNDER THE JURISDICTION OF THE BOURBONNAIS TOWNSHIP PARK DISTRICT

WHEREAS, the Prevailing Wage Act, 820 ILCS 130/0.01, *et seq.*, (the "Act") requires the Bourbonnais Township Park District, Kankakee County, Illinois (the "District") to investigate and ascertain the prevailing rate of wages as defined in that Act for laborers, mechanics and other workers in the locality of the District employed in performing construction of public works, for the District;

NOW THEREFORE, BE IT ORDAINED, by the President and Board of Park Commissioners of the Bourbonnais Township Park District, Kankakee County, Illinois, as follows:

SECTION 1: The statements set forth in the preamble to this Ordinance are true and correct and are adopted as part of this Ordinance.

SECTION 2: To the extent and as required by the Act, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Bourbonnais Township Park District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Kankakee County area as determined by the Department of Labor of the State of Illinois as of June 1, 2011. A copy of that determination is attached to this Ordinance as Exhibit 1 and is incorporated by reference into it. The definition of any terms appearing in the Act shall control the definition of those same terms in this Ordinance.

SECTION 3: Nothing contained in this Ordinance shall be construed to apply the general prevailing rate of wages ascertained in this Ordinance to any work or employment except public works construction of the District to the extent required by the Act.

SECTION 4: The Secretary to the Board of Commissioners of the Bourbonnais Township Park District is authorized and directed to perform the following acts:

- a. Publicly post this Ordinance or keep a copy available in the District's main office for inspection by any interested party;
- b. Promptly file a certified copy of this Ordinance with both the Secretary of State of the State of Illinois and the Department of Labor of the State of Illinois;
- c. Publish notification of the passing of this Ordinance in a newspaper of general circulation within the area.

SECTION 5: The publication described in Section 4.a. of this Ordinance shall constitute notice that the determinations made in this Ordinance are effective and that these are the determinations of the President and Board of Park Commissioners of the Bourbonnais Township Park District.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
