

# Bourbonnais Township Park District Board of Commissioners Meeting Exploration Station... a children's museum 1095 W Perry Street, Bourbonnais, IL 60914 April 25, 2022 at 5:30 P.M.

The April 25, 2022 Board of Commissioners Meeting was called to order by President Hebert at 5:30 pm with the following people present:

**Public Comment-** Bart Durbin, North West Territory Alliance, handed out packets to the board explain the Clash on Kankakee that he would like the board to consider bringing back to Perry Farm. They would be looking at having it here in June 2023. Discussion was had and the board noted they would consider it and be in touch with Mr. Durbin.

Oath of Office- Amanda Langlois, Board Secretary inducted Jeff Mullinax to the Board of Commissioners with the Oath of Office. The board congratulated Mullinax as new Board Commissioner.

Before staff reports, Hebert thanked staff for working hard, keeping our parks clean, programs running, etc. He led into wanting to honor Nicole Jenkins with a PRIDE Award. She was asked to be an Interim Director for the Recreation Station and did so willingly. He explained her accomplishments and length of service with the district.

## **Staff Reports:**

Interim Executive Director Piatt went over the items he has accomplished in a short amount of time:

- Doug Bright Architect- getting proposals for roofs, barns, sheds & maintenance barns
- Working with Historical Society on replacing windows
- Reviewing and assessing the operating budget to present to the board at the next meeting
- Organizational chart redone and posted on website
- Coyne Street dam in need of repair. D&D Construction is evaluating and preparing a proposal for repairs. A claim was filed on 04/25/22 with PDRMA
- Leadership advisory council was formed and met on 4/22/22 and includes 6 staff for training regarding leadership, organizational culture, and working committee on advisory status regarding district problems.
- Revised employee manual, waiting for approval from board tonight.
- Negotiations with Herb Forkenbrock regarding contract for 2023 season at Diamond Point

- Temporary pickleball court was introduced at Rec Station outside. Working with Village of Bourbonnais to use, at no cost, Keno Park tennis courts as a court
- Reviewing existing pay scales for the district
- Continual assessment of existing programs and the introduction of new community partnerships to maximize assets and provide wide opportunities for patrons
- Continue to meet with staff and review programmatic needs and opportunities
- Regenerate and optimize the organizational culture of the BTPD and promote unity and branding of one park district. Marketing efforts will be directed to maximize exposure throughout the county and enable us to attract more people for our programs and events

IT- Frank Cianci's report was submitted in the board packet and added he has been busy with support since things are picking up and lining up training for staff.

Superintendent of Finance & Personnel-Paula Rogers passed out financials with a report on seasonal hiring. She stated we implemented a hotline, 444, for employees to call and leave messages with any HR issues. Rogers is working on budget as well as working with Susie Warner from HomeStar Insurance getting our insurance packages ready for this year.

Superintendent of Recreation- Nicole Jenkins report was submitted in the board packet. Jenkins stated that the recreation department is busy working on summer camp and busy planning fall programs. She also noted that as hard as it was, the district decided to not offer our adult softball league.

Superintendent of Parks- Mike Crews report was submitted in the board packet. Crews added he has been busy with work orders and getting facilities ready for summer. He is still assembling staff for summer.

Marketing- Cherie Smolkovich's report was submitted in the board packet. Smolkovich thanked the Village of Bourbonnais, especially Lindy Casey, for partnering with us on the very successful Easter Egg hunt we had. She is working on Family Night Out which she will have more information at the next meeting on that.

Special Recreation- The report was submitted in the board packet. Settle added that they are in the process of looking through applicants for the new Executive Director for the RVSRA. He also stated that a family donated \$10,000 to the Special Recreation.

Kankakee County Convention & Visitors Bureau- No minutes submitted. Piatt stated he will attend his first meeting with them in May.
