Superintendent of Recreation-Nicole Jenkin's report was submitted with the board packet and she briefly went over it stating that we have hired 2 new part time staff members and 1 new full-time staff member. We also canceled programs from Wednesday through Thanksgiving because of several Covid cases. Basically, as a precautionary for the safety of students, parents and staff during the holidays.

Superintendent of Parks- Mike Crews report was submitted with the board packet. Crews stated they are continuing cleaning the parks up, fixing the pasture area and getting ready for winter. He also added that supplies for the roof for Perry Farm house are on back order.

Marketing- Cherie Smolkovich's report was submitted in the board packet. She reminded everyone about Christmas on the Farm is December 3 from 9 am to 3 pm if any Commissioner would like to volunteer. Smolkovich also added that social media and our website traffic is way up which is awesome, the winter brochure is done and has been sent to the printers and the Chocolate Tour tickets will go on sale on December 14, 2022 at 9 am.
