

Bourbonnais Township Park District Board of Commissioners Meeting Willowhaven Park & Nature Center 1451 N 4000 E Rd, Kankakee, IL 60901 August 26, 2019 at 5:30 P.M.

The August 26, 2019 Board of Commissioners Meeting was called to order by President Delabre at 5:30 pm with the following people present:

Herb Forkenbrock talked about the 2019 softball season. Rain was an issue but Mike Crew's employees did a great job. He would like to continue working with the park district. A meeting is set up for September 11, 2019 to discuss the contract.

## **Staff Reports:**

Executive Director: Hollice Clark submitted his monthly Executive Director Report with the August 26, 2019 board packet. He stated that tonight everyone has a copy of the Ballpark Sports Contract, the last 3 years revenue data sheets from the softball weekends, an Intergovernmental Agreement with the Bradley School District and an informational packet about the Foundation. Brian Scott will be looking over the Intergovernmental Agreement, Clark just wanted the board to have a copy to look it over as well. Clark thanked the board for allowing him to attend the NRPA Directors School last week. He will send notes from the class. Hoppy Pig is remodeling the storage facility that we currently rent. They would like us out by October or November. Clark will work on an intergovernmental agreement with the Bourbonnais School District to house our buses there. We also

need to find a 3000 square foot or more building to rent for storage for 6 months or longer. Clark also mentioned that Bourbonnais Fire Dept. is looking at the possibility of housing their rubberized boat at Perry Farm.

Finance & Personnel: Paula Rogers submitted her monthly finance report with the August 26, 2019 board packet. She also sent electronically the updated financials and handed out the final copy of the Budget Books.

Recreation Station: Sarah Winkel submitted her monthly report with the August 26, 2019 board packet. Fall brochures are out and are amazing. Summer Camp is done and Tammy Marcotte and Jen Blair did a great job. Winkel will be meeting with PDRMA on September 26, 2019.

Diamond Point: Mike Crews submitted his monthly report with the August 26, 2019 board packet. Crews mentioned his seasonal help is all back to school, he is working on maintenance items of things that can't during the season, and fall ball along with Jr High School ball is running well.

Parks & Grounds: Joe Galloy submitted his monthly report with the August 26, 2019 board packet. He has decided to break his report into each facility so the board sees a better picture of what is being worked on. Rec Station had new hand rails installed, new mulch was added and gutters cleaned and fixed. At Willowhaven they have been sealing all of the wood structures throughout the park. The Exploration Station is in good shape, strictly weeding the area. And around the farm, working on cutting and weeding, fixing chicken coop, removed hornets' nest and bathrooms in pavilions almost all fixed. Galloy was shocked and impressed at the crowd of National Night Out and how well all of the organizations worked together. BTPD was a big influence as well.
