

Bourbonnais Township Park District Board of Commissioners Meeting Willowhaven Park & Nature Center 1451 N 4000 E Rd, Kankakee, IL 60901 September 23, 2019 at 5:30 P.M.

The September 23, 2019 Board of Commissioners Meeting was called to order by President Delabre at 5:30 pm with the following people present:

Doug Bright from Bright Architecture handed out a proposal of a new maintenance building for Willowhaven, This building will not be heated, no cement floor, no electricity but could be added at a later time. It will be a basic FBI or Morton building. There is an alternate in the plans for a concrete slab. It will be a wood constructed building with poles and metal panels and it will be red to match the current Willowhaven facility. Bids will be opened on October 2, 2019.

Tom Breitenbucher from the River Valley Special Recreation came to thank BTPD for their continuous support to RVSRA. He stated we are great to work with and that our staff is amazing. Programs, summer camp & trips are at an all-time high in attendance. Breitenbucher also mentioned they purchased a 14 passenger bus, replaced the roof on the facility and launched a new website. November 2, 2019 is the next Great Mouse Race.

Staff Reports:

Sharon Richardson went first to discuss monthly reports since she needed to leave quickly for Sleepy Hollow practice. Her monthly report was submitted with the September 23, 2019 board packet. She added the Scarecrow Festival was a success, hoping the Haunted Trail will be as well, tickets go on sale for that October 1, 2109. Richardson is also working on the Annual Report.

Executive Director: Hollice Clark submitted his monthly Executive Director Report with the September 23, 2019 board packet. Fall is here and the team did an amazing job decorating. Scarecrow Festival was a success and Business Before Hours is October 2, 2019 from 7:30-8:30 am. Clark handed out an Economic Alliance report. He stated that Dennis Crawford from the Bourbonnais Elementary School District, will help us store our busses. As far as a storage facility, Clark is working on it. Hebert asked if the board packet could be less in size. Clark said he would look into seeing if we could have a master copy of the packet for the Open Meetings Act so that each board member would not have to have as much in the packet and he will also look into IPADS for the board.

The next brochure is in process, the restrooms at the Rec Station are wonderful, and the Car Show was a huge success. Hebert congratulated Tammy Marcotte and staff on the Car Show. Winkel also added that Preschool will begin Sept 9.

Diamond Point: Mike Crews submitted his monthly report with the September 23, 2019 board packet. Crews added he is busy doing end of the year maintenance and weed control. Plus they've hosted St George Regionals and came and helped with the corn stalks for decorating the farm and Sleepy Hollow.

Parks & Grounds: Joe Galloy submitted his monthly report with the September 23, 2019 board packet. Galloy went over each facility's items that he has been working on. At the Rec Station, basic mowing and fixed air conditioner. At Willowhaven, seal coating is almost complete on all outside items. At the Exploration Station, he said that Brittaney Beck, Kristi Schu and Tammy Anderson did a great job with shut down and his guys did not have to help much. As far as Perry Farm, the pavilion restrooms are all working, a new chicken coop was built, they got all corn stalks needed for Scarecrow Festival and Sleepy Hollow, and planted 500 plants around the Reflection Garden with the help of Mike Crews and his employees.
